This selective, post-emergent herbicide kills Crabgrass, Dallisgrass, Dandelion, Nutgrass, Goosegrass, Sandbur, Foxtail, and Witchgrass in Merion Bluegrass, Kentucky Bluegrass, Red Top, Tall Fescue, Zoysia and Bermuda turf lawns. Do not use on St. Augustine, Carpet or Centipede Grasses.

**HOW TO USE:** Remove cap from applicator head. Check that applicator head is screwed firmly on jug. Turn jug upside down to allow stream of product to contact weed growth. Hold container 2 to 6 inches from weeds to be treated. Width of product stream may be adjusted by raising or lowering the height and angle at which you hold the container. Apply enough product to thoroughly wet undesirable weed growth.

**IMPORTANT:** Apply Super K-Gro Ready-To-Use Crabgrass Killer when weeds are actively growing and during warm weather. Soil should be moist before treatment. During dry spells water thoroughly before making application. If possible, wait 2 days after application. New turf should not be treated for two weeks or until after the third mowing.
