This product is formulated for use on Merion Bluegrass, Kentucky Bluegrass, Red Top, Tall Fescue, Zoysia and Bermuda turf lawns. DO NOT USE ON ST. AUGUSTINE, CARPET, OR CENTIPEDE GRASSES.

**HOW TO USE (1 gal.):** Remove yellow cap from white applicator top. Be sure that applicator top is securely tightened on bottle. Turn bottle upside down to apply stream of product to weeds. Apply enough product to cover the weed. Width of product

stream may be adjusted by raising and lowering the height and angle at which the container is held.

**HOW TO USE (24 OZ.):** Adjust the nozzle to a coarse spray. Hold the container close to the weed (1-2 feet) and apply to cover the plant, but not to the point of run-off.

**IMPORTANT:** Apply this product when weeds are actively growing. For best results, apply during warm weather and when the soil is moist. During dry spells, it is recommended that the lawn be watered the day before applying this product. A second application on hard to kill weeds is recommended within 5-7 days. New turf should not be treated for two weeks or until after the third mowing.

**NOTE:** Some turf grasses may show temporary discoloration but will return to normal within several days. **DO NOT ALLOW SPRAY TO CONTACT** desirable flowers, trees, shrubs or vegetables.
