**WHERE TO USE:** OUTDOORS - Spray the edges of gardens and flower beds, patches of lawn, trunks of trees, the bases of shrubs, mailbox posts, garbage containers, etc. Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. INDOORS - Spray old cloth or rag and place in area of home where pets are not permitted. Do not spray directly on carpet, upholstery or floors.
