IMPORTANT: TO AVOID DAMAGE OR POOR RESULTS, CAREFULLY READ ALL DIRECTIONS AND PRECAUTIONARY STATEMENTS.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USING. Direct spray away from face and body. Use as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, waterbugs and other insects listed below. Do not use as a space spray. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where these pests are found or may occur.

Care should be taken to avoid depositing this product onto exposed surfaces. Avoid contamination of food or food processing surfaces. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed. Spray surfaces until wet. Repeat as needed.

FOR SPOT TREATMENT

To kill ants, cockroaches, crickets, silverfish, spiders, sowbugs, and carpet beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and door and window frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and... other utility installations. Pests driven out of hiding places should be sprayed directly. For ants,

apply to ant trails, and around doors, windows and other areas where they can find entrance. Repeat as necessary.

To kill brown dog ticks and fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.**

FOR CRACKS AND CREVICICES

To kill ants, cockroaches, crickets, silverfish, sowbugs, spiders, brown dog ticks, fleas and carpet beetles: Apply spray directly into cracks and crevices where pests may hide.

Flies: Use only out of doors as an aid in reducing annoyance from these pests. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, patios and garages where these pests may congregate. Flies coming to rest on treated surfaces will be killed. Repeat treatment as necessary.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Keep container closed.

Disposal: Replace cap and discard in trash. Do not incinerate or puncture.
