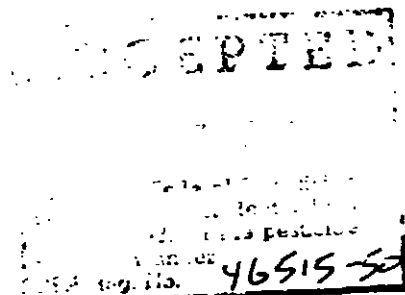

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. FOR OUTDOOR USE AROUND THE HOME ONLY.

Where to use: [Edger II] [This product] is a herbicide that kills vegetation and prevents regrowth for up to three months. It controls unwanted annual and perennial vegetation around shrubs, trees, buildings, patios, in brick and gravel walkways and along fences, driveways, sidewalks and curbs. It will not stain paved or gravel areas. DO NOT USE AS A SPOT TREATMENT IN LAWNS. DO NOT USE IN OR AROUND VEGETABLE GARDENS, FRUIT OR FEED CROPS.

When to use: This product may be used anytime during the year when vegetation is actively growing. For best results, apply during warm, sunny weather. Do not apply during windy conditions, as spray drift may injure non-target plants. Visible effects on vegetation will occur within one week, with complete kill in 2 to 4 weeks. New growth will be prevented for up to 3 months. Some hard to control perennial weeds may require a second application. If rainfall occurs within 6 hours of treatment, a repeat application may be necessary.

How to use: SHAKE BEFORE USING. Remove cap from applicator top. Ensure applicator top is securely tightened on bottle. Invert container and adjust spray to the desired width and pattern by

changing the angle and height at which the bottle is held. For edging around lawns, fences and sidewalks, and controlling vegetation around trees, shrubs and buildings, hold container 6 to 12 inches from area to be treated. For controlling weeds in large areas, such as gravel walks and driveways, hold container about waist high and away from body and walk slowly making sure all undesirable vegetation is thoroughly covered. Apply at a rate of about 1 gallon per 200 sq.ft. If spray contacts desirable vegetation, immediately wash off with water.

**STORAGE & DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Protect from freezing and high temperatures. Store in original container, preferably in a locked storage area inaccessible to children and pets. Do not store near fertilizer, seed or feed products.

**Disposal:** Do not reuse empty container. Securely wrap in several newspapers and put in trash collection.

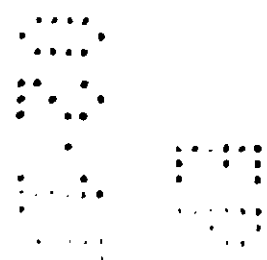
