To control Bedbugs: Spray mattresses lightly, particularly around tufts and seams. Take beds apart and spray in all joints. Treat baseboards, moldings and floors. Repeat as needed.

To control fleas (adult and larvae) and Ticks (including ticks that carry Lyme
