Fill the area with the mist at the rate of 1 ounce per 1,000 cubic feet. Leave area closed for 30 minutes. Ventilate thoroughly before re-entry. Sweep up dead insects.

In boxcars, ship cargo holds, barges and trucks, apply to loose or unpackaged finished foods with paper or plastic. Apply space spray at a rate of 1 fl. ounce per 1,000 cubic feet of space. Close all doors and openings before spraying and leave closed for 30 minutes after total application. Ventilate thoroughly before re-entry and destroy dead insects.

CONTACT SPRAY: To kill all listed crawling insects, spray directly whenever possible. Direct contact insects in cracks and crevices, in floor drawers, base boards, around pipes, beams, behind machinery and other harborages. Spray the areas until wet. Repeat as necessary. In restaurants, shelves and drawers should be allowed to dry, then covered with shelf paper. Any utensils contacted with spray should be washed before use to avoid contamination of feed or food stuffs.

If surface application is to be used, spray floors, walls and other surfaces applying at a rate of 1 gallon to 1,000 cubic feet. Apply with care, this spray could cause damage to surfaces.

IN MUSHROOM PRODUCTION AND PROCESSING: To control mushroom flies or fungus gnats in growing areas, apply at a rate of 1 ounce per 1,000 cubic feet. Fogger should be operated 8 to 10 feet away from growing area, directed slightly upward over them. Circulating fans should be left in operation, but for best results, refrigeration should be turned off. In packing and canning plants, use at a rate of 1 ounce to 2,000 cubic feet of space.

Ventilate thoroughly before re-entry. Sweep up and destroy dead insects.

In boxcars, ship cargo holds, barges and trucks, cover any loose or unpackaged finished foods with paper or plastic tarp. Apply space spray at a rate of 1 Fl. ounce per 1,000 cubic feet of space. Close all doors and openings before applying spray and leave closed for 30 minutes after total dosage has been applied. Ventilate thoroughly before re-entry. Sweep up and destroy dead insects.

CONTACT SPRAY: To kill all listed crawling insects. Adjust spray to produce large wetting type spray particles. Apply spray directly whenever possible. Direct spray to contact insects in cracks and crevices, in floors, shelves, drawers, base boards, around pipes, beams, behind cabinets, around machinery and other harborages. Spray these infested areas until wet. Repeat as necessary. In homes and restaurants, shelves and drawers should be allowed to dry then covered with shelf paper. Any utensils that are contacted with spray should be washed before using. Avoid contamination of feed or food stuffs.

If surface application is to be used, spray floors, walls, and other surfaces applying at a rate of 1 gallon to 750 square feet. Apply with care, this spray could cause staining.
