DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a maniner inconsistent with its labeling. This product must be applied out-of-doors to wood intended only for exterior use.

SURFACE CONDITIONS: wood to be treated should be clean, dry and free of mildew.

 WEATHER CONDITIONS: DO NOT apply if rain is forecast within 12 hours. Temperatures should be 45° or above for 24 hours <u>before</u> and <u>after</u> application

APPLICATION DIRECTIONS: STIR THOROUGHLY BEFORE & OCCASIONALLY DURING USE. DO NOT SHAKE.

Apply by dipping, brush, long nap roller or spray. (Garden sprayers work well.) A lan spray pattern is desirable. Apply a heavy or well-on-well application that DOES NOT RUN OR SAG. ("A wet-on-well application is when the first application of material is still wet and a second coat is applied to help in completing penetration.)




