Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage

areas and wherever these pests are suspected of hiding. For control of ants, treat doors, window sills, ant trails and other areas of entry. Repeat as necessary for control.

To Kill Carpet Beetles: Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be spraying thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.

To Kill Exposed Forms of Confused Flour Beetles, Sawtoothed Grain Beetles, Lesser Grain Borer, and Rice Weevils: Find and destroy infested package goods. Remove all other items from pantry. Spray the shelves to kill any of the named insects present. Place clean paper on the shelves and return packages after shelves have dried. Repeat as necessary.

To Kill Wasps: Contact insects directly with spray. Sweep up and discard fallen wasps. Repeat as necessary.
