Apply liberally to all exposed skin areas. To apply to face, spray on hands and rub on. Repeat as needed. For ticks and chiggers, also apply liberally to shoe tops, socks and around openings in clothing.

Avoid contact with plastics, such as eyeglass frames, and such fabric as acetate rayon.
