CAUTION

## STATEMENT OF PRACTICAL TREATMENT

If in Eyes: Flush with plenty of water. Get medical attention if irritation persists.

If on Skin or Clothing: Remove contaminated clothing. Wash skin with soap and warm water. Get medical attention if irritation persent.

If inhaled: Remove to fresh air if effects occur, and call physician.

If Swallowed: Do not induce vomiting because of possible hazard. Call a physician immediately

## STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame.

Disposed: "On not conteminate water, food, or feed by storage or disposed." "Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposed facility." "Wrap container and put in trash collection."

General: Use this product as a spot or crack and crevice treatment to control cockrosches, waterbugs, silverfish, ticks, fleas and other insects listed below. Apply this product as a coarse spray to localized areas where pests are found or may occur. Spray surfaces until wet. Recent as needed.

### SPOT TREATMENT

To kill Ants, Rosches, Crickets, Silverfish, Sowbugs, Spiders and Esneigs: Spray into cracks, crevices, around haseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Contact directly as many insects as possible. For ants, spray trails and places where ants enter premises. Repeat as necessary for control.

To Kiti Brown Dog Ticks and Flees: Remove and destroy old bedding. Spray sleeping quarters of pets, around baseboards, windows and door frames, wall cracks, and localized areas of floors. Repeat as necessary. Fresh bedding should be placed in animal quarters after apray has dried. Do not spray animals. To control the source of your infestation treat your pets with a product registered for application to animals.

To KIII Carpet Bestles and Dermettida: Spray along baseboards, edges of carpeting under carpets and rugs, under furniture, in closets, on shelving, and in other places of harbourage. Repeat as necessary.

For Crack and Crevice: Application within food lianding establishments (Places other than private residences, in which food is held, processed, prepared or served) including but not kimited to restaurants, grocery stores, bakenes, bottling plants, cannenes and grain mills: To kill ants, roaches, crickets, silverfish, sowbugs, spiders, earwigs, brown dog ticks, fleas, carpet beetles and dermestids: Use as a spot treatment in and around both food and non-food areas where the above pests have been seen or are suspected of hiding or entering.
