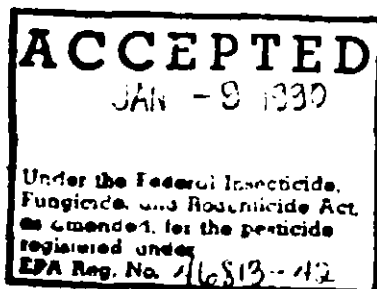

Control of Wasps and Hornets:

It is preferable to apply this after dark when all the insects have returned to the nest. Insert attached extension tube into actuator to enable you to deliver a pin stream. Aim extension tube at the nest and depress button, continuing to spray until the nest is all covered with the insecticide foam. The insects will now not be able to leave the nest so insert the extension tube into the nest and fill the nest with the insecticide foam.
