**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION

Harmful if swallowed or absorbed through skin. Avoid breathing vapors of spray mist. Avoid contact with skin and eyes. In case of contact immediately flush skin or eyes with plenty of water. Obtain medical attention if irritation persists. If swallowed, do not induce vomiting. Call a physician immediately.

STATEMENT OF PRACTICAL TREATMENT

If In Eyes: Flush with plenty of water. Get medical attention if irritation persists.

If on Skin or Clothing: Remove contaminated clothing. Wash skin with soap and warm water. Get medical attention if irritation persists.

If Inhaled: Remove to fresh air if effects occur, and call physician.

If Swallowed: Do not induce vomiting because of possible hazard. Call a physician immediately.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame.

Disposal: "Do not contaminate water, food, or feed by storage or disposal or cleaning of equipment." "Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility." "Do not re-use the empty container" "Wrap container and put in trash collection." "Do not puncture or incinerate."

PHYSICAL HAZARDS

Contents under pressure. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Do not use this product in or on electrical equipment due to the possibility of shock hazard.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labelling. Do not use in food areas of food handling establishments.

CONTROL OF WASPS AND HORNETS:

It is preferable to apply this after dark when all the insects have returned to the nest. Insert attached extension tube into actuator to enable you to deliver a pin stream. Aim extension tube at the nest and depress button, continuing to spray until the nest is all covered with the insecticide foam. The insects will now not be able to leave the nest so insert the extension tube into the nest and fill the nest with the insecticide foam.
