**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION

Harmful if swallowed. Avoid breathing vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food or feedstuffs. Do not spray in pet's eyes, face or on genitalia. Do not use on nursing puppies or kittens under 3 months of age. Do not use this or any other pesticides on sick, old or debilitated pets.

Physical or Chemical Hazards

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately.
IF ON SKIN OR CLOTHING: Remove contaminated clothing and wash before re-use. Wash skin with soap and water. Get medical attention if irritation persists.
IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.
IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame.
Dispose: Do not re-use empty container. Wrap original container in several layers of newspaper and discard in trash. Do not puncture or incinerate.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill fleas up to 14 days on dogs and cats and will kill ticks for 4 days on dogs and 9 days on cats.

Shake can well before using. Hold can about 1 inch above pet's back and spray the foam from pet's head to tail. Using protective mitts or gloves, rub the foam thoroughly into the pet's coat using a comb, brush or hand. Be sure that foam is worked thoroughly into pet's coat down to the skin. Do not spray in face, eyes, or on genitalia. Repeat weekly if necessary.
