Dear Mr. Jankowski:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable, provided you make the labeling changes indicated below prior to release for shipment of the product bearing the amended labeling:

1. The header change from "STATEMENT OF PRACTICAL TREATMENT" to "FIRST AID", is acceptable. However, the change from "DIRECTIONS FOR USE" to "NOTICE TO USER" is unacceptable. Please revise.
2. The statement, "Do not use this product in or on electrical equipment due to the possibility of shock hazard" should be moved under "PHYSICAL OR CHEMICAL HAZARDS."
3. Your labeling indicates that repeat applications may be necessary. The retreatment statements should include a maximum frequency of application. For example: "... but not more than ___ times per ___."

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

May be harmful if swallowed, inhaled or absorbed through skin, avoid breathing spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing. In case of contact, immediately flush skin and eyes with plenty of water. Wash thoroughly with soap and water after handling and before smoking. If poisoning occurs, get prompt medical aid.

Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms but excluding areas where food may be prepared or held. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers) entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

In the home, all food processing surfaces and utensils should be covered during the treatment, or thoroughly washed before use. Exposed food should be covered or removed. Not for use in Federally Inspected Meat and Poultry Plants.

Remove pets, birds and cover fish aquariums before spraying. Do not allow children or pets to contact treated surfaces until spray has dried. Do not apply to classrooms when in use.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Environmental Hazards: This product is extremely toxic to fish and aquatic organisms. Use with care when applying to areas adjacent to any body of water. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of waste. Apply this product only as specified on the label.

FIRST AID

IF SWALLOWED: Call a physician or Poison Control Centre immediately. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol. IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists. IF INHALED: Remove victim to fresh air. Apply artificial respiration if needed. IF ON SKIN OR CLOTHING: Remove contaminated clothing. Wash skin with soap and warm water. Get medical attention if irritation persists.

NOTICE TO USER

It is a violation of Federal law to use this product in a manner inconsistent with its labelling.

Do not use this product in or on electrical equipment due to the possibility of shock hazards. For Spot/Crack and Crevice Treatment Only. Do not use as a space spray.

STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame. DO NOT FREEZE.

Disposal: Do not re-use empty container. Securely wrap original container in several layers of newspapers and discard in trash.

GENERAL

Use this residual spray as a spot or crack and crevice treatment to control cockroaches, waterbugs, silverfish, ticks, fleas and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

FOR SPOT TREATMENT

DIRECTIONS:

To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, Earwigs, and Carpet Beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets; in and around garbage cans, and barbecues; and around plumbing and other utility installations. Pests driven from hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards; window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do not Spray Pets with This Product. Pets should be treated with a registered product for flea and tick control in conjunction with this treatment.

To Kill House Flies, Horse Flies, Face Flies, Deer Flies, Stable Flies, Cluster Flies, Horn Flies and Mosquitoes: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of windows and doorframes as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.

REPELS SPIDERS/KILLS SPIDERS ON CONTACT-ODORLESS, COLORLESS, WON'T STAIN-RESIDUAL-FOR USE IN NON FOOD AREAS ONLY

To Control Spiders, apply CCL Crawling Insect Killer XI only as spot or crack and crevice treatment to localized areas where spiders are found or may hide. Shake can well before using. Spray surfaces until wet. Repeat as needed. Spiders driven from hiding places should be sprayed directly.

EXTERIOR: On boats spray hatches, screens, vents and any other areas where spiders may enter vessel. Spray in and around sail covers, rub rails, engine compartments, garbage cans and barbecues. Repeat as necessary. On planes spray Engine Cowling, Pilot Tubes, Wheel Pants, Ailerons, Landing Gear, Struts, Hangar rafters and any areas where spiders may hide or enter. Repeat as necessary. In RV's, spray places where spiders may enter: screens, doors, window frames, light fixtures, generator wells, vents, and awnings. Repeat as necessary.

INTERIOR: On boats spray into cracks, crevices, bilge, engine compartment, behind and beneath cabinets, sinks, stoves, refrigerators, around plumbing, waste containers, hatches and any other places where spiders may hide. Repeat as necessary. On planes spray windows, doors, storage compartments, seat bases, and any other places where spiders may hide. Repeat as necessary. In RV's, spray into areas where spiders may hide: crack and crevices, under sinks, around cabinets, lower parts of stoves, waste containers, baseboard, equipment, garbage cans, and barbecues. Repeat as necessary.
