- Delete the following implied safety claims
 "without persistent residue problems"
 "meets CARB, DPR VOC regulations, VOC % content, Percent VOC formulation."
 "bealth and safety inquiries"
- Delete the following marketing claims, which are vague and detract from the directions for use:
 Domestic use. Commercial use. Agricultural use.

The product chemistry submission is acceptable. The basic and alternate confidential statements of formula A, B, & C dated February 23, 2006 are acceptable and have been placed in the file jacket for this registration. Alternate confidential statement of formula D, dated May 12, 2006, will be processed in a separate action, as there was no response to a phone conversation on May 22, 2006 with the EPA Product Manager regarding an extension to the PRIA due date.

A copy of the efficacy review is attached.

Submit two copies of the revised final printed label for the record.

This product [[product name]] may also be used on listed livestock and horses for quick control [kill] of pests on these animals.

This product [[product name]] may be used in listed pet quarters. This product [[product name]] provides fast, effective control [kill] and repels the lists pests.

This product [(product name)] may be used in restaurants and other listed areas to control [kill] on contact listed crawling pests and is a fast, effective product for flying insect control. Effectively controls [kills] exposed stages of stored product pests without persistent residue problems because it breaks down quickly on treated surfaces exposed to light.

[This product is] For use in/on: Animal holding areas, animal quarters, ant hills, attics, barns, beef barns, bottling plants, buildings housing animals or poultry, calving barns, canneries, commercial buildings, crematoriums, dairy barns, dairles, dried fruit storage areas, dumpsters, factories, farm structures, food processing plants, food storage areas, funeral pariors, garbage cans, goat holding areas, grain elevators, grain storage, hog barns, homes, horse stables, hotels, industrial plants, institutions, kennels, kitchens, livestock holding areas, loafing sheds, mausoleums, milk houses, milk rooms, milk sheds, milking rooms, mortuaries, pet sleeping areas, poultry houses, railroad cars, restaurants, rice mills, seed storage, sheep holding areas, ships, stables, storage areas [sites], stored products, supermarkets, swine houses, theaters, tobacco warehouses, trailers, trucks, utility rooms, veterinaries, warehouses, washrooms and wheat mills.

Read All Directions Completely Before Use

For most effective results follow the directions for each specific use area.

Shake Before Use and at Intervals During Prolonged Use.

Hold container upright with nozzle pointed away from face. Press valve down and spray as directed.

For use in Animal Quarters (barns, dairies, milking parlors, milking rooms, poultry houses and other listed animal areas): For rapid control [kill] of flies, mosquitoes, gnats and flies (black, deer, horn, horse, house, lesser house and stable): Spray at the rate of 5 to 10 seconds per 1000 cubic feet of space, directing the spray toward the ceiling and upper corners and not directly toward the animals or birds. For best results, close doors

and windows, if possible, before spraying and keep them closed for 10 to 15 minutes after spraying. Applicators must vacate the treated area and ventilate it prior to returning.

For Use on Livestock:

To protect beef cattle, dairy cattle, horses and other livestock from attacks and to kill and repel Flies (Stable, Horse, Deer, House, Horn and Lesser House), Mosquitoes and Gnats, spray approximately 3 seconds on each side being careful to thoroughly spray back, withers and forelegs.

To protect from Face Flies, spray the face and head or spray on a cloth and rub on the face being certain to avoid contact with the eyes. Repeat treatment as necessary when flies are troublesome.

For effective control of biting and sucking lice on cattle, horses, sheep, goats and hogs, spray to thoroughly wet the hair of the animal including the head and brush of the tail. Repeat treatment in 10 days to kill newly hatched lice.

To control poultry lice and exposed stages of Darkling Beetles, thoroughly spray roosts, walls and nests or cages; then spray a fine mist over the birds.

For control of bedbugs and mites on poultry and in poultry houses, spray crevices of roost poles, cracks in walls and cracks in nests where the bedbugs and mites hide; then spray a fine mist over the birds.

To control sheep "tick" or ked, thoroughly wet all portions of the body by spraying directly into the wool. Treat at a rate to sufficiently wet the animal.

To kill fleas and Ixodid ticks on livestock and to obtain protection against reinfestation, spray to wet the animal.

[Indoor Use:]

[Not for use in food areas or where food processing is underway.]

Space Treatment Indoors:

For maximum efficacy, close all doors and windows, turn off fans and air conditioner and spray upward into center of room with a slow, sweeping motion. Spray 5 to 10 seconds for an average size room [1000 cubic feet] [10 ft. x 12 ft. x 8 ft.]. Keep room closed for 15 minutes after spraying. Ventilate room for 5 minutes before re-entry. For use in Food Areas of Food Handling Establishments: When applying space treatment in food handling areas, the food handling operation must be shut down. In food processing areas, cover or remove all utensits, shelving, etc. where food will be handled before treatment or wash with an effective cleaning compound followed by a potable water rinse prior to use.

Flies, Flying Moths, Gnats, Mosquitoes, and Exposed Stages of Moths (Almond, Angoumois Grain, Chocolate, Clothes, Indian Meal, Miller and Tobacco) and other listed flying insects: Direct spray into all parts of the room, with special attention to hiding places. Sweep up and destroy fallen insects.

Surface Treatment Indoors:

Contact as many insects as possible with this spray. Apply spray at the rate of 30 seconds for each 100 square feet of surface area. Keep area closed for 45 minutes after treatment. Ventilate room 20 minutes before re-entry.

Booklice, Centepedes, Clover Mites, Cockroaches (American, Asian, Australian, Brown Banded, German, Oriental, [Palmetto Bugs,] Smoky Brown [and Waterbugs]), Crickets, Earwigs, Firebrats, Lice, Millipedes, Pillbugs, Scorpions, Silverfish, Sowbugs and Spiders: Thoroughly spray all parts of the room suspected of harboring these

pests. Pay special attention to hiding places such as cracks and crevices, behind and beneath sinks, stoves, refrigerators, around garbage cans, cabinets, along baseboards, door sills, frames and floors, around drains, pipes, plumbing, behind bookcases, storage and other utility installation areas contacting insect with spray whenever possible.

Exposed stages of Beetles (Cigarette, Confused Flour, Drugstore, Flat Grain, Flour, Merchant Grain, Red Flour, Sawtoothed Grain and Warehouse), Cadelles, Cheesemites, Grain Mites, Grain Weevils, Indian Mealworm, Lesser Grain Borer and Rice Weevils: Find and destroy infested package goods [sacks, boxes, cartons, containers]. Remove all other Items from shelves and drawers and thoroughly clean. Spray into cracks and crevices, shelves, drawers, cabinets, processing and handling equipment, around cartons or containers and other areas where these insects tend to congregate.

For use in Cannerles: Prior to bringing in produce, thoroughly clean floors, conveying equipment and walls, with special attention to cracks and crevices. Spray the entire space inside of the cannery including walls, ceiling and floors, paying special attention to forcing the spray into all cracks and crevices for the control of ants, cheesemites, cockroaches, crickets, fruit flies, house flies, moths, silverfish, spiders and other listed insects.

For use in Food and Nonfood Areas of Food Processing Plants, Industrial Installations, Bakeries, Rice and Wheat Mills, Restaurants, Tobacco Warehouses, Grain Elevators and Warehouses: Spray as directed to control listed flying and crawling insects. Confine the use of this product in food processing or food handling establishments to time periods when the plant is not in operation. Cover or remove food during treatment.

For use in Storage Sites: Use this product in warehouse bins and trucks, cargo ships, mills, bin hoppers, elevators and conveying equipment as a clean-up prior to using them for storage. In mills and elevators, remove from the bin hoppers all grain infested accumulations. Thoroughly clean all storage and conveying equipment by sweeping out the waste grain, cobwebs and other debris from the walls and rafters in addition to that on the floor and door frames. Pay special attention to material lodged in the cracks and crevices. Remove and burn all of the debris to kill eggs and insects that might be present.

For farms, give particular attention to cleaning up around the used feed and grain bags, grain residues from wagons, harvesting equipment and feed troughs. Do not place newly harvested grain in the same bin with carry-over grain. Furnigate all carry-over grain stocks that are not treated with this product. Perform these cleaning operations within two or three weeks before harvest.

After these sanitation measures have been employed, spray as directed all areas prior to use for storage.

Ants, Carpenter Ants [Eastern] [Western], Foraging Fire Ants and Pharaoh Ants: Treat doors, around window frames, ant trails and hills and other areas of entry. Spray on ants where possible.

Carpet Beetles [Dermestids (*Trogoderme*)]: Directly spray as many insects as possible. Spray both interior and exterior of furniture. Thoroughly spray both top and bottom of rugs and carpets where possible. Also treat shelves, closets, areas under furniture, floors, walls, baseboards and wherever these insects are seen or suspected.

Clothes Moths and other Flying Moths: Remove any infested articles from storage, thoroughly brush and air for several hours in sunlight, if possible. Apply liberally to empty chests, closets, bureaus and other storage areas directing the spray into cracks, joints and crevices. Return clean articles after spray has thoroughly dried.

Bedbugs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings and floors. Allow treated fabric to thoroughly dry before using.

Fleas and Ticks: For use in Listed Pet Areas: Remove and either launder or destroy pet's old bedding. To reduce infestation, thoroughly spray the animal's clean bedding, sleeping quarters, kennel, around baseboards, window and door frames, wall cracks, local areas of floors and other resting places until the surface is slightly moist. Treat these areas at the rate of 2 seconds per linear foot at a distance of 12 to 18 inches. Also spray the entire inside surface of dog houses. Put fresh bedding in pet's quarters after spray has dried. Allow treated areas to thoroughly dry before allow pets to re-enter. For best results treat pets with an EPA-registered product approved for flea and tick control on pets before allowing pets to return to the treated area. Do not treat pets with this product.

Space Treatment Outdoors:

Adult Mosquito, Fly, Flying Insect and Gnat Control: Use prior to entry outdoors to reduce annoyance from these and other flying pests. Spray around patio, porches, gazebos, shrubbery, vegetation and any other listed areas where mosquitoes may rest. For best results treat when the wind velocity does not exceed 5 miles per hour.

Exposed stages of Moths (Almond, Angournois, Chocolate, Indian Meal, Miller and Tobacco) and other flying moths: Direct spray into all parts of room, especially around stored food product containers, pallets and darkened areas. Furnigate [or treat with EPA-approved products such as {brand name}] infested stored products.
