- 2. Make the following change to the label:
  - a. Change the product registration number to "EPA Reg. No. 46813-69"
  - b. Make the following label revisions:

## Use Site Header section comment(s), page 1 of 2:

- 1. Per the reregistration eligibility decision (RED) documents for pyrethrins, piperonyl butoxide and MGK 264, delete the use sites "Homes, Hospitals and Schools" from the existing use site header beginning with "For use in Food Processing Plants…"
- 2. For the use site listed at the end of the use site header, "Other Public Buildings," you must clarify this statement, since this site could potentially include day-care facilities, nurseries and nursing homes, which have also been deleted as per the REDs for pyrethrins, piperonyl butoxide and MGK 264. If you cannot clarify this statement, then it should be deleted from the label.
- 3. Revise the use site header introduction currently starting with "For use in Food Processing Plants,..." with "For indoor use in the following areas: Food Processing Plants,..."

## Precautionary Statements, Use Restrictions section comment(s), page 1 of 2:

4. Per the REDs for pyrethrins, piperonyl butoxide and MGK 264, add the following new subsection at the beginning of the Directions for Use section, immediately following the statement "It is a violation of..." as follows:

### "Use Restrictions:

- DO NOT remain in treated area. Exit areas immediately and remain outside the treated area until aerosols, vapors and or mists have dispersed.
- Not for use in residential areas.
- DO NOT use in nurseries or rooms where infants, ill or aged persons are confined.
- Remove or cover all food and drinking water before application.
- Remove or cover dishes, utensils, food processing equipment and food preparation surfaces before use or wash them before reuse.
- All food processing surfaces and equipment should be covered or washed with an effective cleaning compound followed by a potable water rinse after use of this product.
- DO NOT use in areas where fish or reptiles may be exposed to the spray.
- DO NOT place metering device directly over or within 8 feet of exposed food, dishes, utensils, food processing equipment and food handling or preparation.
- DO NOT install within 3 feet of air vents.
- Carefully follow directions for the dispenser unit when installing the dispenser and replacing cans or conducting maintenance." <sup>2</sup>

- 5. On the paragraph starting with "Flying Insect Killer I is designed for use...," delete the words or phrases indicated by the "lined out" text in the attached copy of stamped approved label.
- 6. Delete the 7.5 minute application interval since there are no data to support this timing.
- 7. Remove flies from the proposed label and decrease the application rate applied every 15 minutes to 40.59 mg.
- 8. If K-G Packaging, Inc. desires to add flies to this label, they must provide sufficient information that the proposed container delivers ≥71.66 mg of product every 15 minutes.
- 9. Delete the 3<sup>rd</sup> sentence and replace with: "Within 24 hours following treatment, a decrease in the number of flies, gnats, mosquitoes and small flying moths should be noticed and with continued use, annoyance from these pests should also be reduced."
- 10. In the 8th sentence, insert the words "of choice" following the word "unit."
- 11. In the 8th sentence, insert the word "required" following the word "conducting."

## Storage and Disposal section comment(s), page 1 of 2:

- 12. Due to the flammability concern of this product, replace the "Storage" subsection with: "Keep this product dry in a tightly closed (preferably locked) container, when not in use. Store in a cool, dry, well-ventilated area inaccessible to children and pets and away from heat, sparks or open flames."
- 13. Insert the following text as a new subsection immediately following the "Storage" subsection: "Pesticide Disposal: Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance."
- 14. Re-label the existing "Disposal" subsection as "Container Disposal."

## Additional/alternate marketing language section comment(s), page 1 of 2:

- 15. Delete the words or phrases indicated by the "lined out" text in the attached copy of stamped approved label as these are implied claims.
- 16. For the two highlighted comments related to VOC, these claims can remain on the label if the appropriate VOC percentages are specified. If not, delete them.
- 17. Delete the marketing claim "No unpleasant odor," since a fragrance is listed on the CSFs for this product.

## Additional/alternate marketing language section comment(s), page 1 of 2 (continued):

18. Replace the last marketing claim with: "Contains the botanical insecticide Pyrethrins [an extract of the Chrysanthemum flower]."

## Top of Back Panel comment(s), page 2 of 2:

19. Please clarify what is meant by "{Logo;" at the top of this page.

## Precautionary Statements, Hazards to Humans and Domestic Animals section comment(s), page 2 of 2:

- 20. Replace the first four (4) sentences from this section with: "Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing vapors or spray mist. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco. Remove and wash contaminated clothing before reuse. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
- 21. Delete the last seven (7) sentences from this section, starting with "Do not use in nurseries...," as indicated by the "<del>lined out"</del> text in the attached copy of stamped approved label.

## Precautionary Statements, First Aid section comment(s), page 2 of 2:

22. Replace this section with the following:

## Bottom of Back Panel comment(s), page 2 of 2:

- 24. The listing for "[{website}]" at the bottom of this page cannot reference any collateral labels other than what is being approved by EPA for this product.
- 25. Data deficiencies were identified for storage stability and corrosion characteristics in the product chemistry review for this product. Therefore, K-G Packaging, Inc. is obligated to submit a One Year Storage Stability (830.6317) study and a Corrosion Characteristics (830.6320) study on this product in support of this registration within one year from the date of this registration. 4
- 3. Submit two (2) copies of the revised final printed label for the record before the product is released for shipment.

K-G Packaging, Inc. should note that a notice of availability of EPA's reregistration eligibility decision (RED) document for products containing pyrethrins was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389). EPA's RED for products containing piperonyl butoxide was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386). Further, EPA's RED for products containing MGK 264 was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42381-42383). As a result, additional data and/or labeling changes may be required for products containing pyrethrins, piperonyl butoxide and MGK-264.

If the above conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the approved label is enclosed for your records.

### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its 'abeling.

Flying Insect Killer I is designed for use in a wide range of automatic metered dispensers. The dispenser automatically activates the special metered valve every 7.5 and/or 15 minutes. Within 24 hours the area is relatively free of flies, gnats, mosquitoes and small flying meths; with continued use annoyance from these posts is reduced. Effectiveness of this product is noticeable within one hour after the dispenser is activated. Recommended use is for 24 hours; if less than 24 hours is required, set the dispenser to start one hour before control is desired and to run one hour after control is no longer needed. Factors such as airflow rate, size of space treated, humidity and room temperature affect insect activity and control; therefore, consider one unit per 6,000 cubic feet of unobstructed space as the average application rate, making adjustments depending upon specific conditions at the usage site. As with any method of insect control, best results are achieved when sanitation and other positive insect prevention practices are followed. Carefully follow the directions for the specific dispenser unit when installing the dispenser, replacing cans and conducting maintenance.

### Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in a cool (preferably locked) place inaccessible to children and pets and away from heat, sparks and open flame. Disposal: Do not puncture or incinerate! If empty: Place in trash or if available offer for recycling. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
