The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended is acceptable with conditions.

Proposed Amendment

Add disinfectant claim against Staphyloccus aureus- MRSA HA and CA

Conditions

Revise the label as follows:

- 1.) The HIV-1 directions are incomplete such that its various sections are dispersed throughout the proposed label, these statements must be consolidated to reflect the following:
- *KILLS HIV-1 ON PRECLEANED ENVIRONMENTAL SURFACES/OBJECTS PREVIOUSLY SOILED WITH BLOOD/BODY FLUIDS in health care settings or other settings in which there is an expected likelihood of soiling of inanimate surfaces/objects with blood or body fluids, and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of human immunodeficiency virus Type-1 HIV-1(associated with AIDS).

SPECIAL INSTRUCTIONS FOR CLEANING AND DECONTAMINATION AGAINST HIV-1 ON SURFACES/OBJECTS WITH BLOOD/BODY FLUIDS.
