

Dear Mr. Cassinis:

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with comments.

Proposed Amendment

· Updated labeling

Label Comments:

1. Remove the word "Treatment" from the first aid heading and revise text to read as follows:

"First Aid"

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a Poison Control Center or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 1-20 minutes. Call Poison Control Center or doctor for treatment advice.

IF SWALLOWED: Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told by a Poison Control Center or doctor.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration preferably mouth-to-mouth if possible. Call a Poison Control Center or doctor for further treatment advice.

"In case of emergency call (insert toll-free emergency number if available)."

"Have the product container or label with you when calling a Poison Control Center or doctor or going in for treatment."

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.

2. The Precautionary Statement heading must read as follows:

Precautionary Statement

Hazards to Humans and Domestic Animals

3. The Agency noticed that the precautionary statement language has been changed from the original label, which was accepted on September 2, 1982. There are no acute toxicity data on file to support the current label language. Therefore, the precautionary statement must be revised to read as follows:

Precautionary Statement
Hazards to Humans and Domestic Animals

Danger: Corrosive. Causes eye damage or skin burns. Fata if swallowed or absorbed through skin. Do not get in eyes, on skin or on clothing. Avoid breathing spray mist. Wear goggles or face shields (safety glasses), protective clothing (long-sleeve shirt and long pants, sock, plus shoes and chemical resistant gloves such as water proof gloves). Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash before reuse.

A stamped copy of the label is enclosed for your records. Submit three (3) copies of the revised final printed label before distributing or selling this product.

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

Thoroughly clean surface of items to be disinfected and rough dry. ProPhene is a concentrated solution and must be diluted 1:32 with water prior to instrument soak and/or decontamination of dental and medical instruments or disinfection of hard environmental surfaces. This product is not to be used as a terminal sterilant/high-level disintectant on any surface or instrument that (1) is introduced directly into the . human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) " contacts intact mucous membranes but which does. ... not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high-level disinfection.

Immerse items in diluted ProPhene solution for instrument soak and/or decontamination of medical and dental instruments. For disinfection of hard environmental surfaces such as walls, figors and countertons, diluted ProPhene should be mooned, soonged, snrayed or wiped in a manner to thoroughly wet the surface. A properly prepared solution of ProPhene intended for use as a hard surface disinfectant, has a shelf life of 60 days (use life) when stored in a closed container such as a spray bottle.

A contact time of 10 minutes at 20°C (68°F) with a 1:32 dilution of ProPhene has been shown to be effective on bacteria including: Escherichia Coli 0113, Staphylococcus aureus, Salmonella typhosa, Pseudomonas aeruginosa, Mycobacterium tuberculosis; fungi including: Trichophyton mentagrophytes; viruses* including Polio virus 1, Coxsackie B2, Influenza virus type A1 (New Jersey) and influenza B (Maryland). Herpes virus types 1 and 2. Vaccinia virus and HIV-1.

Rinse articles thoroughly following immersion. Discard the used solution daily or sooner if It becomes diluted or soiled.

For use on metals, plastics, rubber and glass. Glass may etch over prolonged or repeated exposure to concentrated solutions. Do not store tensed articles in concentrated [coPhena.

SPECIAL INSTRUCTIONS FOR CLEANING AND III **DECONTAMINATION AGAINST HIV (Human** Immunodeficiency Virus) DN SURFACES OR OBJECTS SOILED WITH BLOOD OR BODY FLUIDS.
