**PRECAUTIONARY STATEMENTS**  
**HAZARDS TO HUMANS & DOMESTIC ANIMALS**  
**CAUTION**

Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists. If swallowed, do not induce vomiting. Call a physician immediately.

Do not apply directly to food. Commercial food handling facilities, cover or empty any food and food processing equipment during application. Do not apply while food processing is under way. After space spray in food processing plants, wash all equipment with potable water, benches, shelving, etc., where exposed food will be handled. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use.

Remove pets and birds, and cover fish aquariums before spraying. Use 12' or more from exposed foods. Do not use close to varnished surfaces. Do not use in nurseries or rooms where infants, ill or aged persons are confined.

**STATEMENT OF PRACTICAL TREATMENT**

**IF SWALLOWED** — Call a physician or Poison Control Center immediately. Gastric lavage is indicated if material was taken internally. **DO NOT INDUCE VOMITING:** Vomiting may cause aspiration pneumonia.

**IF INHALED** — Remove victim to fresh air. Apply artificial respiration if indicated.

**IF ON SKIN** — Remove contaminated clothing and wash affected areas with soap and water.

**IF IN EYES** — Flush eyes with plenty of water. Get medical attention if irritation persists.

**PHYSICAL OR CHEMICAL HAZARDS**

Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperature above 130° F may cause bursting. Never throw container into fire or incinerator.
