CRAWLING INSECTS

Roaches, Waterbugs, Säverlish, Fleas, Spiders: Direct spray behind baseboards, molding, sinks and pipes, toward drains and dark corners, into cracks, crevices, recesses and similar hiding places. For the control of roaches, waterbugs and silverfish make thorough and repeated spraying of the infested area, working the spray into cracks and other hiding places. Be sure to hit the insects directly with the spray. Make repeated applications as necessary. For the control of flees in premises, special care should be made to treat the floors, baseboards, floor coverings, wall cracks, as well as the sleeping quarters of the animals. Hit the insects directly with the spray. Repeat treatment as required.

HOME AND FOOD PROCESSING AREA USE: For flies, mosquilloss, small flying moths (millers), and gnats: Close all doors and windows. Point nozzle upward, direct the spray mist to all parts of the room, especially windows and other light sources which attract these insects. Fill the room with mist, then leave the treated areas. Keep the room closed for at least 15 minutes. Ventilate the room when treatment is completed. Roaches, Waterbugs, Sowbugs, Spiders and Centipedes: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards and storage areas. Spray directly on insects where possible. Repeat as necessary. ANTS: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

STORED PRODUCT INSECTS (accessible stages): Flying Mediteranean flour moths, Indian meal (chocolate) moths, angumols grain moths: Close doors and windows. Direct aerosol mist to all parts of the room, especially into dark enclosures and around stored product containers where adult moths may be resting. Use a minimum treatment of six to eight seconds per 1000 cubic feet of space. Keep area closed for 30 minutes after each treatment. Repeat treatment weekly or as flying moths appear. Infested stored food products should be furnigated or treated with an approved product.

DAIRY FARM USE: Milking parlor and milk room. Close all windows and doors. Scray at the rate of 1 to 2 seconds per 1000 cubic feet. If rooms cannot be closed, double the dosage. Stand in middle of room. Direct spray in all directions. Keep room closed for 15 minutes after treatment. Do not remain in treated area. Ventilate the area after treatment is completed. Cover milking utensils and milk to prevent contamination from apray and dead or falling insects.

DAIRY ANIMAL USE: From approximately 2 foot distance thoroughly spray entire animal as it is being released to pasture. Do not spray directly toward animal's eyes. Spot treat withers, shoulders and back where saliva accumulates from head tossing.

STANCHION BARN USE: Walk behind animals and direct apray over backs allowing 1 second per animal. For most effective results, apply each morning.

HOG OPERATIONS: In hog houses, close all windows and doors. Apply at the rate of 1 to 2 seconds per 1000 cubic feet. Keep area closed for 15 minutes following application. If area cannot be closed, double the dosage For animal application directspray over backs and spray for 1 to 2 seconds per hog. Do not spray directly towards animal's face or eyes. Repeat application daily or as necessary.

HORSE BARNS AND STABLES: In horse and pony barns close all windows and doors. Spray at the rate of 1 to 2 seconds per 1000 cubic feet. Keep area closed for 15 minutes following application. If area cannot be closed, double the dosage. In animal application, lightly mist over backs of horses and ponies.

BEEF CATTLE OPERATIONS: In barns, close all windows and doors. Apply at the rate of 1 to 2 seconds per 1000 cubic feet. Keep and closed for 15 minutes following application? If area cannot be closed, double the dosage. For animal use, thoughly spray entire animal as it is being refeased to pasture. Do not spray directly towards animal's face or eyes. Repeat application daily or as necessary.

POULTRY OPERATIONS: For poultry houses, close at windows and doors. Spray at the rate of 1 to 2 seconds pe 1000 cubic feet. Keep area closed for 15 minutes following application. If area cannot be closed, double the dosage. Treat daily or as necessary.

Clothes Moths: Thoroughly spray clothing and fabric articles with special altention to folds and searns. Repeat monthly unless stored in moth-proof containers. Keep bomb at least 3 feet away from clothing or fabrics being sprayed.

For controling ents in the house, treat ant traits and areas around door sits and window frames where the pests enter the premises. Be sure to hit the ants directly with the spray. Make repeated applications as required.

Bedbugs: To kill bedbugs, spray all crevices of mattresses, springs, cracks in baseboards, bedroom furniture, where bedbugs may hide. Repeat as necessary.
