Note to physician: POISONING SYMPTOMS: Symptoms include weakness, headache, tightness in chest, blurred vision, non-reactive, pin-point pupils, salivation, sweating, nausea, vomiting, diarrhea and abdominal cramps. Probable mucosal damage may contraindicate the use of gastric lavage.

TREATMENT: Atropine is the specific therapeutic antagonist of choice against parasympathetic nervous stimulation. If there are signs of parasympathetic stimulation, Atropine Sulfate should be injected at 10 minute intervals of occurred of 1 to 2 mgs. until complete atropinization has occurred. Pralidoxime chloride (2-PAM) may also be used as an offictive antidote in addition to and while maintaining full atropinization. In adults, initial dose of 1 gram of 2-PAM should be injected, preferably as an infusion in 250 cc of saline over a 15 to 30 minute period. If this is not practical, 2-PAM may be administered slowly by intravenous injection as a 5 percent solution in water over not less than two minutes. After about an hour, a second dose of 1 gram of 2-PAM will be indicated if muscle weakness has not been relieved. For infants and children the dose of 2-PAM is 0.25gram. Morphine is an improper treatment.

Clear chest by postural drainage. Oxygen administration may be necessary. Observe patient continuously for 48 hours. Repeated exposure to cholinesterase inhibitors may, without warning, cause prolonged susceptibility to very small doses of any cholinesterase inhibitor. Allow no further exposure until cholinesterase regeneration has been attained, as determined by blood test.

DANGER

Corrosive. Causes irreversible eve damage. Causes skin burns. May be fatal if absorbed through the skin. Harmful if swallowed. Do not get on skin, in eyes, or on clothing.

Use on lawns, turf or ornamentals is prohibited. Use in residential sites as a crack and crevice or space spray is prohibited.

ANIMAL BUILDINGS - Horse Stables, Auction and Show Barns - (Flies, Gnats and Mosquitoes), Apply 0.5% VAPONA Insecticide as a fog or mist. One quart of a 0.5% solution will treat 8000 cubic feet (40'X20'X10'). Remove animals prior to treatment. Before applying, reduce air movement as much as possible by closing doors, windows and other openings. Do not use this solution for fogging or misting purposes in areas where animals have received a direct application of dichlorvos or other organophosphate within eight hours. Apply as necessary, but no more than once per day. Do not contaminate water, feed or foodstuffs, milk or milking utensils.

Other Uses – Animal Building, Milk Sheds, Outdoor Areas – (Flies, Gnats, Mosquitoes, Roaches, Fleas, Ants, Sowbugs, Brown Dog Ticks). Apply 0.5% Vapona Insecticide as a coarse wet spray at the rate of one quart per 1000 square feet. For milk sheds, stables, livestock barns, pig pens, and outdoor areas treat around doorways, feed storage rooms, alleyways and window sills. Do not contaminate milk or milking utensils. In poultry houses, apply to manure, window sills outside of penned enclosures and on floor of feed storage rooms.

Treat outdoor living areas, picnic grounds, backyard areas, patios, loading docks, outdoor latrines, parking areas, refuse areas around service stations, open-air drive-ins, garbage collection and disposal areas.

In treating dog kennels apply to outside dog runways, window sills, and ledges. For control of fleas and brown dog ticks increase dosage to two quarts 0.5% VAPONA Insecticide per 1000 square feet.

Before applying in enclosed areas, reduce air movement as much as possible by closing doors, windows and other openings. Do not remain in treated areas and ventilate the area after treatment is complete. Do not treat animals or humans.
