Your amended application of April 25, 1997

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the following changes and submit one (1) copy to us before you ship your product:

1. Change "FIRST AID" to read:

IF SWALLOWED ... person.

IF INHALED, Remove victim to fresh air. If not breathing, give artificial respiration preferably mouth-to-mouth. Get medical attention.

IF IN EYES, Flush with plenty of water. Call a physician if irritation persists.

IF ON SKIN, wash with plenty of soap and water. Get medical attention.

2. Make sure that the subheadings for the "PRE-TREATMENT DIRECTIONS" of the use directions are "left justified",

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Dust pet thoroughly, including head (except eyes, mouth, and nose), back, sides, legs, ears, and tail. Avoid any sores. Rub into fur. Dust sleeping quarters and replace bedding if necessary.

Do not reapply product for 1 week

Storage: Store only in original container, in a dry place inaccessible to children and pets.

Disposal: Do not reuse empty container. Rinse thoroughly. Wrap securely in newspaper and discard in trash.
