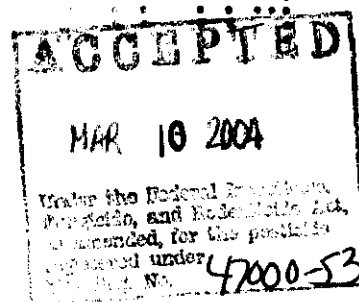

Fly Wipe-Away is a Space spray giving quick knockdown and kill of flies, mosquitoes and gnats in barns.

Horses: This product will kill horse flies, stable flies, house flies, hornflies, face flies, mosquitoes and gnats on the animal at the time of application.

Use a heavy cloth or sponge to wipe spray on animal. Apply just enough spray to wet the ends of the hair but not enough to soak the hide to protect against attack and annoyance by these insects. Repeat at daily intervals or as necessary to give continued protection.

Face Flies: Use a heavy cloth or sponge to wipe spray on the faces of horses. Apply daily or as needed to those areas of the animal where face flies rest, such as the face, withers, and sides where saliva may occur from head tossing.

Barns: Apply as a mist spray in barns to knock down and kill stable flies, horse flies, face flies, mosquitoes and gnats. Close all windows and doors before spraying and keep them closed for 10-15 minutes after the room has been filled with a light mist. **NOTE:** Do not remain in treated areas and ventilate the area after treatment is completed.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Store in a cool, dry, secure area in original container.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
