A multi-use insecticide repellent formulation which may be applied to animals to protect them from biting and nuisance flies, mosquitoes, and gnats.

NOTE: Do not use this product on heated or wet animals as it may cause blistering.

Fly Wipe-Away can be used a Space spray giving quick knockdown and kill of flies, mosquitoes and gnats in barns.

Horses & Ponies: This product will kill horse flies, stable flies, house flies, horn flies, face flies, mosquitoes and gnats on the animal at the time of application. Do not use on horses intended for slaughter.

Use a heavy cloth or sponge to wipe spray on animal. Apply just enough spray to wet the ends of the hair but not enough to soak the hid to protect against attack and annoyance by these insects. Repeat at daily intervals or as necessary to give continued protection. Application must not exceed 0.00025 lbs ai/animal or 2 oz of .2% spray/animal. Do not apply more than 1 time per day.

Face Flies: Use a heavy cloth or sponge to wipe spray on the faces of horses. Apply daily or as needed to those areas of the animal where face flies rest, such as the face, withers, and sides where saliva may occur from head tossing.

Horse Stables and Sheds: Apply as a mist spray using a good quality ULV spray in stables to knock down and kill stable flies, horse flies, face flies, mosquitoes and gnats. Close all windows and doors before spraying and keep them closed for 10-15 minutes after the room has been filled with a light mist. NOTE: Do not remain in treated areas and ventilate the area after treatment is completed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

<u>PESTICIDE STORAGE:</u> Store in a cool, dry and secure area. Store in original sealed container away from food or feed.
