Spray Concentrate For Horses is especially prepared for use on horses of all breeds and ages. (Not to be used on horses intended for slaughter for meat.) This product is a concentrate. Always dilute with water as directed before application.

Dilute 1 1/2 fl. ozs. (3 tablespoonful) in a pint of water. Thoroughly mix. Spray or sponge on animal to dampen the coat. Do not wet horses skin. 1 to 2 ounces per animal per day gives adequate protection. Give particular attention to the legs, shoulders, shanks, neck and facial areas where flies most often are seen. Cover eyes while spraying face, or apply to face as a wipe. Repeat treatment as necessary when flies are troublesome.

Horses may be ridden or worked immediately upon drying following application.
