The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. A stamped copy is enclosed for your records.

The revised formula, deleting perchloroethylene (PCE), has been included in our files. Use of PCE as a diluent, carrier, or solvent in this formulation would no longer be consistent with the terms of its registration.

Refer to the Resmethrin Standard concerning its declaration as an active ingredient.

Submit the study on which the claim "flame extension = negative" is based. Include all details of the test and identify the test substance. We believe the FLAMMABLE or EXTREMELY FLAMMABLE markings may be required for this pesticide.


