#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE. KEEP CONTAINER UPRIGHT.

This product will kill Ants, Cockroaches, Confused Flour Beetles, Crickets, Fleas, Houseflies, Mosquitoes, Pill Bugs, Rice, Weevils, Saw-toothed Grain Beetles, Small Flying Moths and Ticks.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

To Kill Fleas and Ticks: Destory pet's old bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to re-entry.
