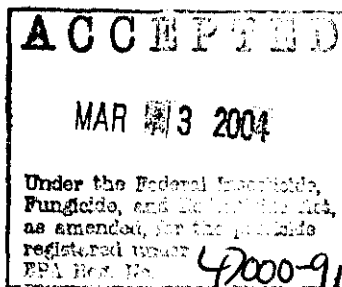

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**SHAKE WELL BEFORE USE. KEEP CONTAINER UPRIGHT.**

This product will kill Ants, Cockroaches, Confused Flour Beetles, Crickets, Fleas, Houseflies, Mosquitoes, Pill Bugs, Rice Weevils, Saw-toothed Grain Beetles, Small Flying Moths and Ticks.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Do not remain in the areas during treatment and ventilate thoroughly before re-entry.

Do not use more than one fogger per room. Do not use in small, enclosed spaces such as closets, or under counters or tables. Do not use in rooms 5 ft x 5 ft or smaller; instead allow fog to enter from other rooms. Turn off ALL ignition sources such as pilot lights (shut off gas valve), other open flames or running electrical appliances that cycle off and on (i.e. refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance.

**TO OPERATE VALVE:** To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

**To Kill Fleas and Ticks:** Destroy pet's old bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to re-entry.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Store in a cool, dry place away from children, preferably a secure storage area.
