## **USE RESTRICTIONS**

Remove or cover exposed food and drinking water before application.

Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use.

When used as a space spray or fog, do not remain in treated area. Exit area immediately and remain outside the treated area until aerosols, vapors, and/or mists have dispersed. Do not allow adults, children, or pets to enter until vapors, mist, and aerosols have dispersed and the area has been thoroughly ventilated.

Do not apply this product in a way that will contact workers or other persons either directly or through drift. Only protected handlers may be in the area during application.

Do not apply directly to sewers or drains, or to any area like a gutter where drainage to storm sewers, waterbodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

Use specific rate/application restrictions for these active ingredients are as follows:

- The maximum Piperonyl Butoxide (PBO) rate per day for indoor crack and crevice spray is 0.56 lbs. ai/1,000 square feet; and for space sprays is 0.025 lbs ai/1000 cubic feet per day.
- The maximum Pyrethrin rate per day for space spray is 0.0033 lbs a.i./1000 cubic feet; and for crack/crevice or spot surface is 0.22 lbs. ai/1000 square feet.

When used in indoor food handling/processing facilities: Do not make space spray applications when facility is in operation. Prior to space spray applications, cover or remove food, cover food processing surfaces or clean after treatment with a suitable detergent rinse with potable water before use. Remove or cover exposed food and drinking water before application. Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use. Do not apply more than 1 time per day.

For direct application to non-domestic animals/livestock: Do not apply more than 1 time per day. When used in in Dairy Barns or facilities: close milk bulk tank lids to prevent contamination from spray and from dead or falling insects. Remove or cover milking utensils before application. Wash teats of animals before milking. Products must be formulated to deliver no more than this maximum rate when used according to directions: Space sprays when non-domestic animals are present -0.008 lb ai/ 1000 cubic feet/day.

Remove pets, birds (except in commercial poultry operations) and cover fish aquaria before spraying. Avoid exposure of reptiles to this product

Not for use in outdoor residential misting systems.

#### **PREPARATION NOTES**

Warm this product to room temperature and mix well before each use. Keep sprayer unit clean to ensure proper delivery. Calibrate equipment often.

## **APPLICATION INSTRUCTIONS**

This concentrate is designed for use undiluted or diluted in mechanical sprayers which gives particles of aerosol size. It can also be diluted with water and applied as a contact spray. The Pyrethrin concentration of dilutions recommended on this label can be determined from the following table:

### FOR USE IN

Grain Elevators, Feed Storage Areas, Farm Buildings, Dairy and Beef Barns, Horse Barns, Swine Housing, Milking Parlors, Milk Rooms, Dairies, and other Animal Quarters, Food Processing Plants, Industrial Sites.

#### See restrictions pertaining to use in food areas and milking areas.

Before application, clean thoroughly interior and exterior of all handling equipment and completely remove all accumulations of dust, grain, and other infested or waste food and feed products from bins and storage areas.

#### SURFACE SPRAYING

Kills: Cockroaches, Waterbugs, Ants, Beetles, Crickets, Silverfish and Sowbugs. Dilute 1 part concentrate to 9 parts water and spray all surfaces where insects crawl or rest, on walls, in cracks and crevices, building entrances, partitions, under and behind equipment, shelves, cabinets, and counters and to all areas where insects harbor. Apply as a coarse wetting spray, at the rate of 1 gallon diluted solution per 750 square feet. Do not apply on surfaces which could be stained by water. Repeat as necessary, but no more than once per day (24 hours).

#### **SPACE TREATMENT – UNDILUTED**

This method of application will control exposed, accessible stages of flies (including fruit flies), mosquitos, Asian beetles, gnats, small flying moths, wasps, hornets, clover mites, cheese mites, cheese skippers, boxelder bugs, earwigs and the following common stored product pests: granary weevils, rice weevils, confused flour beetles, saw-toothed grain beetles, spider beetles, cigarette beetles, drugstore beetles, Angoumois grain moths, Mediterranean flour moths, Indian meal moths, tobacco moths, yellow mealworms, grain mites, cadelles and red flour beetles.

Close windows and doors and shut off air conditioning and ventilating systems. Use a fogger, aerosol generator or other equipment adjusted to deliver an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns). Apply at a rate of 2.5 to 5 fluid ounce per 1000 cubic feet of space. Direct the spray toward the ceiling and upper corners of the space and behind obstructions. Keep the area closed for at least 30 minutes. Vacate the treated area and ventilate before occupying. Sweep up and destroy fallen insects. Repeat treatment if re-infestation occurs, but not more often than 1 time per day.

#### **SPACE SPRAY, DILUTED**

**General:** For use in ordinary mechanical fogging equipment to control accessible exposed stages of flies (including fruit flies), mosquitoes, small flying moths, gnats, wasps, hornets, cheese skippers and these stored product pests: granary weevils, rice weevils, confused flour

beetles, saw-toothed grain beetles, spider beetles, cigarette beetles, drugstore beetles, Angoumois grain moths, Mediterranean flour moths, Indian meal moths, tobacco moths, mealworms, and grain mites. Close room and shut off air conditioning or ventilating equipment. Dilute 1 part concentrate plus 9 parts water and mix well. Apply at the rate of 1 to 2 fluid ounces per 1,000 cubic feet filling the room with mist. Direct spray upward towards the corners of room and ceiling. Vacate the treated area and ventilate before occupying. Sweep up and destroy fallen insects. Keep area closed for at least 30 minutes. Do not apply more than 1 time per day.

# LIVESTOCK USES

**Poultry Houses:** Chicken Mites and Bedbugs. For Chicken Mites, dilute 1 part concentrate to 19 parts water. Apply liberally and thoroughly as a driving spray with particular attention to perch poles, nests and cracks in floor and walls. Spray litter thoroughly. For Bedbug control dilute 1 part concentrate to 9 parts water. Repeat treatment when needed but do not apply more than 1 time per day.

# LIVESTOCK

## To protect beef and dairy cattle, horses, swine, goats and sheep:

**Lice:** Dilute 1 part concentrate to 1000 parts water. Apply as a thorough coating spray or dipping to wet all parts of body. Usually 1 1/2 to 3 gallons in required for horses or cattle and 2 to 4 quarts for sheep, goats, and swine. Repeat as needed.

Sheep Ticks: Dilute 1 part concentrate to 49 parts water. Apply as a spray or by dipping to wet all portions of body.

## Cattle, Horses, Goats, Swine, and Sheep:

Horse Flies, Stable Flies, and Deer Files: Dilute 1 part concentrate to 9 parts water. Horn Flies and Mosquitoes: Dilute 1 part concentrate to 19 parts water.

Apply as a spray at the rate of about 1 quart per animal to wet hair over entire body. Apply a light mist, sufficient to set the tips of the hair with particular attention to the legs and underline. Application should be SUFFICIENT TO WET HAIR BUT NOT TO SOAK THE HIDE. Repeat treatment once daily to give continued protection. Do not use more than 1 time per day.

To control face flies on beef and dairy cattle, use sufficient material to wet the face and head but do not spray into the eyes. Repeat as necessary when flies are troublesome, but not more than once per day (24 hours).

# STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Keep container tightly closed when not in use. Do not store with food or food stuffs. Store in a cool, dry, well-ventilated area.

**Pesticide Disposal:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. Fill the container <sup>1</sup>/<sub>4</sub> full with appropriate spray oil and recap. Shake for 10 seconds. Pour rinsate into application equipment or mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
