This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Disconnect electrical power. Fog for 1 to 5 seconds per 1,000 cubic feet, but use no more than 1 gallon per 64,000 cubic feet. Do not fog into or near an open flame. Occupants should vacate premises before treatment and should not reoccupy the premises until it has been ventilated. Leave treated area closed for at least 15 to 30 minutes, and then open windows and doors to ventilate.
