The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Do not rinse off. Repeat as necessary for control.

Do not use on dogs or cats under 12 weeks old. Consult a veterinarian before using this product on medicated, debilitated, aged, pregnant or nursing animals. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water.
