

## DIRECTIONS FOR USE

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTANT WITH ITS LABELING.

## INDUSTRIAL RECIRCULATING WATER COOLING TOWERS AND EVAPORATIVE CONDENSERS

GENERAL DIRECTIONS: For controlling the growth of bacteria and algae in industrial recirculating water cooling towers, and evaporative condensers.

INDUSTRIAL RECIRCULATING COOLING WATER TOWERS AND EVAPORATIVE CONDENSERS: BADLY FOULED SYSTEMS should be cleaned prior to initiating treatment.

1. Initial Dosage - When the system is just noticeably fouled, add 0.4-0.5 lbs. of S103P per 10,000 gallons of water contained in the system. Repeat this dosage if necessary until a free available chlorine level (FAC) of 0.5-1.0 ppm is obtained (as determined by use of a reliable test kit).
2. Maintenance Dosage - To maintain a FAC of .5-1.0 ppm add 0.8-1.6 oz. of S103P per 10,000 gallons of water, daily or as needed.
3. S103P should be added to the system at a point where adequate flow is maintained. Variations in water temperature, chlorine demand and flow rate will affect dissolution rate. Warmer seasons may require an upward adjustment of the FAC.
