DIRECTIONS FOR USE

Apply with a regular sprayer giving a coarse spray for the control of flies. Not a space spray. Will not mix with water. Caution — Do not spray near open flame, pilot lights, heating elements, or other sources of heat.

DAIRY BARNS, HOG AND POULTRY HOUSES — Spray directly on walls, ceilings, stanchions, partitions, window and door frames wherever flies alight or congregate until surfaces are moistened. Repeat as necessary. Do not spray directly on animals.

MILK HOUSES — Spray directly on walls, ceilings, door and window frames wherever flies alight or congregate. Do not spray milking equipment. Re-treat as necessary.
