The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, to change the name of the company on the product label, is acceptable, provided that you comply with the items listed below.

1. As per PR Notice 2001-1, the heading Statement of Practical Treatment must be changed to "First Aid" and the instructions must be revised as follows:

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.

IF SWALLOWED:

Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor.

IF ON SKIN:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment.

IF INHALED:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment.

In addition, the following general statement is **required** to be included with the First Aid instructions, preferably, at the end of the statement.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

2. Submit two (2) copies of final printed labeling for our review. A stamped copy of the labeling is enclosed for your records.

LEATHER PROCESSING LIQUORS: For use in controlling the growth of bacteria and fungi in the pickling and tanning process of skins and hides. Depending upon the holding time, add at a rate of 0.025% to 0.25% (0.25 to 2.5 lbs. of SM-10P per 1,000 lbs.) of white weight stock. FOR CONTROL OF SLIME IN PAPER MILLS: For control of slime consisting of bacteria, fungi and/or algae apply at the rate of 2-8 ounces (59-237 mL) by weight per ton of finished paper. Add intermittently or continuously depending on mill requirements. Apply at point well ahead of area of need and where immediate dispersion of water solution is not required, preferably where stock is of high consistency such as beater, hydrapulper, and broke chest.

FOR CONTROL OF MICROBIAL ORGANISMS IN RECIRCULATING COOLING WATER TOWERS, RETORT WATER SYSTEMS, AND EVAPORATIVE CONDENSERS: initially add 6 to 12 ounces (177-355 mL) per 1000 gallons of water. Repeat daily until controlled. Thereafter, add 3 to 6 oz. (89-177,mL) three times, per week or as needed to maintain control. Add at central point where uniform mixing is assured (12oz. per 1000 gal. [355mL/3.8k1]=9.3 ppm active; repeated dosing may increase this level).

SM-10P controls microbial slime consisting of bacteria, fungi, and/or algae. SM-10P may be used in heat exchangers, recirculating cooling towers, and water passing through filters which could become clogged with slime. Not for use in once-through water towers.
