



OX LINE STAIN AND WOOD PRESERVATIVE SOLID COLOR

OX LINE oil stain and wood preservative is formulated to protect wood surfaces against fungi that causes mildew staining and wood rotting. Recommended for use on shingles, shakes, fences and smooth or rough cut wood siding. CAUTION: Not recommended for primed or previously painted surfaces and wood which comes in ground contact. Also, do not use on decks and other high-wear areas. May be applied to previously stained surfaces of similar or lighter color.

In most cases, one coat is sufficient for full protection. For porous or badly weathered surfaces, a second coat is recommended. Solid color stain coats the surface and penetrates the wood, allowing the wood texture to show. If repainting eventually is desired, surface must be well weathered (6-9 months).

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Surface must be clean and free of dirt, oil, grease and mildew. Consult dealer for removing mildew to restore natural tone of wood. Mix well before application. Always buy enough stain for the complete job. Close container after each use.

APPLICATION: Apply liberally, covering a small area at a time and keeping a wet edge to avoid lap marks. Work in the direction of the wood grain. Do not stop in the middle of an area; work to edges or corners. If possible, avoid direct sunlight when applying by following the shaded side around the house. Do not apply over wood that is painted or varnished. Since wood itself may vary in color and texture, and different woods show stain differently, test the stain first on similar type wood.

WARNING: CONTAINS PETROLEUM DISTILLATES. Use only with adequate ventilation. Avoid prolonged breathing of vapor or spray mist. Causes substantial but temporary eye injury.
