Dear Ms. Holcombe,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Proposed Amendment

- Update Storage and Disposal per PRN 2007-4
- Update Company Address and add optional statements

Conditions

Revise the label as follows:

- 1) The Environmental Hazards must be revised to be in agreement with the ADBAC RED by adding the statement, "This pesticide is toxic to fish and aquatic invertebrates."
- 2) AOAC has updated the species nomenclature for Salmonella choleraesuis to Salmonella enterica. Revise the nomenclature on page 2 accordingly.
- 3) Since this product is used as a disinfectant in food processing facilities, revise the "Disinfection" directions by adding the statement, "Before use in federally inspected food processing facilities, food products and packaging materials must be removed from the room or carefully protected."

3) The "Disposal of Infectious Material" statement under HIV directions on page 3 must be								
brought into compliance with PR Notice 2000NCURRENCES ory labeling, by deleting the term

- 4) The Container Rule rescinded PR Notice 83-3 and 84-1 Part II in which Container Disposal statements are no longer separated by container size but by use pattern. Delete the "Storage and Disposal" Instructions for containers one gallon or less w/ uses other than household/residential. Also revise the first "Note to reviewer" to read "Containers for household and residential uses," and the third "Note to reviewer" to read "Containers for institutional/industrial/commercial uses."
- 5) Revise the "Container Disposal" statements for commercial/industrial/commercial uses to read:

Container Disposal: Nonrefillable container. Do not reuse or refill container. Clean container promptly after emptying.

(Containers 5 gallons or less [please note that the statements are the same for plastic and metal containers])

Triple rinse as follows: Fill container ¼ full with water and recap. Agitate vigorously. Follow Pesticide Disposal instructions for rinsate disposal. Drain for 10 seconds after the flow begins to drip. Repeat procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

(Container greater than 5 gallons [please note that the statements are the same for plastic and metal containers])

Triple rinse as follows: Fill container ¼ full with water. Tip container on its side and roll it back and forth, ensuring at least one complete revolution for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into the application equipment or mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

(For Bag in Box Containers): Proposed language acceptable.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS DANGER. Corrosive. Causes irreversible eve damage and skin burns. Do not get in eyes, on skin, or on clothing. Wear protective eyewear (goggles, face shield or safety glasses), protective clothing and protective gloves (rubber, chemical resistant) when handling. Harmful if swallowed. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DISINFECTION DIRECTIONS: Use 4 fl. oz. of Formulation HS-32Q per gallon of water, for a minimum contact time of 10 minutes, in a single application. Pre-clean all surfaces prior to disinfection. Thoroughly wet surfaces with a mop, sponge, cloth, coarse sprayer or by soaking. Wipe dry with a clean cloth or sponge or allow to air dry.

For sprayer applications, use a coarse spray device. Spray 6 - 8 inches from the surface; rub with a brush, sponge or cloth. Do not breathe spray.

Rinse all surfaces that come in contact with food such as countertops, appliances, tables and stovetops with potable water before reuse. Do not use on utensils. glassware and dishes.

Prepare fresh solution daily or more often if the use solution becomes visibly diluted or dirty.



(Note for reviewer: For labels that list medical premises and metal and / or stainless steel surfaces, one of the following statements must be used:)

This product is not to be used as a terminal sterilant / high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection

FOR FUNGICIDAL ACTIVITY: Formulation HS-32Q is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) in areas such as locker rooms, dressing rooms, shower and bath areas and exercise facilities. Follow disinfection directions.

TO CLEAN AND DISINFECT TOILET BOWLS AND URINALS:

To clean, squeeze around the bowl and under the rim. Leave for 10 minutes or overnight if possible. Swab, then flush.

To disinfect, first preclean to remove heavy soil, then remove or expel over the inner trap the residual bowl water prior to applying the use dilution. Use 4 fl. oz. of Formulation HS-32Q per gallon of water. Apply to exposed surfaces including under the rim with a cloth, mop sponge or coarse sprayer. Brush or swab thoroughly, allow to stand for 10 minutes and flush. Close cap on container after each use.

TO CLEAN AND DEODORIZE: Mix 4 oz. of Formulation HS-32Q per gallon of water to clean and deodorize surfaces. Apply using a cloth, mop, sponge or sprayer. Wipe or allow to air dry.

FLOOR AND WALL CLEANER

Use in USDA federally inspected meat and poultry plants as a floor and wall cleaner in all departments. Before use of this product, food products and packaging materials must be removed from the room or carefully protected. Apply with mop, cloth, or sponge at a dilution of 4 fl. oz. per gallon. After use of this compound, all surfaces in the area must be thoroughly rinsed with potable water.

VETERINARY PRACTICE / ANIMAL CARE / ANIMAL LABORATORY / ZOOS / PET SHOP / KENNELS DISINFECTION DIRECTIONS:

For cleaning and disinfecting hard nonporous surfaces: equipment used for animal food or water. utensils. instruments, cages, kennels, stables, catteries Remove all animals and feeds from premises, animal transportation vehicles, crates, etc. Remove all litter, droppings and manure from floors. walls and surfaces of facilities occupied or traversed by animals. Empty all feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Saturate surfaces with a use-solution of 4 oz. of FORMULATION HS-32Q per gallon of water (or equivalent dilution) for a period of 10 minutes. Wipe or allow to air dry. immerse all halters, ropes and other types of equipment used in handling and restraining animals as well as forks, shovels and scrapers used for removing litter and manure. STORAGE AND DISPOSAL

Store in original container in areas inaccessible to children.

Nonrefillable container. Do not reuse or refill this container. Wrap [container] and put in trash or offer for recycling if available.

Nonrefillable container. Do not reuse or refill this container. Wrap [container] and put in trash or offer for reconditioning if appropriate.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Open dumping is prohibited. Store in original container in areas inaccessible to children.

Pesticide Disposal:
