Dear Ms. Holcombe,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Proposed Amendment

- Update Storage and Disposal per PRN 2007-4
- Update Company Address and add optional statements

Conditions

Revise the label as follows:

1) The Environmental Hazards must be revised to be in agreement with the ADBAC RED by adding the statement, "*This pesticide is toxic to fish and aquatic invertebrates.*"

2) The nomenclature for Herpes Simplex Type 1, Influenza A/Texas, Rubella, Vaccinia, Avian influenza, and Avian infectious bronchitis on page 2 is incomplete. You need to indicate that the microorganisms are viruses by stating "Herpes Simplex *Virus* Type 1, Influenza A/Texas *Virus*, Rubella *Virus*, Vaccinia *Virus*, Avian Influenza *Virus*, and Avian infectious bronchitis *Virus*.

3) Revise the last claim in the right column on page 2 to be incompliance with PR Notice 2000-5, Mandatory Labeling, by deleting the term, recommended.

4) The Personal Protection statement under "HIV-1" instructions on page 3 must be revised by deleting the term, or, and stating "*and*" because the personal protection equipment is not optional

5) The "Disposal of Infectious Materials" statement under the "HIV-1" instructions on page 3 must be brought into compliance with PR Notice 2000-5, Mandatory Labeling, by deleting the term, should, and stating "*must*."

6) Revise the 5th step under "Farm Premise and Poultry House" on page 3 to be incompliance with PR Notice 2000-5, Mandatory Labeling, by deleting the term, recommended.

7) The Container Rule rescinded PR Notice 83-3 and 84-1 Part II in which Container Disposal statements are no longer separated by container size but by use pattern. Delete the "Storage and Disposal" Instructions for containers one gallon or less with uses other than household or residential.

General Comments

A stamped copy of the label accepted with conditions is enclosed. Submit three (3) copies of your final printed label before distributing or selling the product bearing the revised labeling.


