- A. Appearance: A colorless to pale yellow liquid with a mild solvent odor. Congealing may occur during prolonged storage at low temperatures; product will return to homogeneous state upon warming to room temperature.

- C. pH (10% solution in distilled water): 6.0 - 8.0
- D. Activity: 50% min.
- E. Color (Gardner): 3 max.
- F. Average molecular weight: 361
- G. Amine Hydrochloride: 2.75% max.
- H. Free Amine plus Amine Hydrochloride: 3.0% max.
- I. Flash Point (TCC): 114° F.
- J. Solubility: Freely soluble in water, lower alcohols, ketones, and glycols.
- K. Compatibility: FMB 210-15 Quat is compatible with detergent builders, organic chelates, nonionic surface active agents, and most polar solvents. FMB 210-15 Quat is cationic; and therefore, its effectiveness is reduced by soap and anionic surface active agents.




