DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

GENERAL USE DIRECTIONS

USES: For laundering fabrics such as diapers, institutional linens and athletic apparel in hospitals, nursing homes, schools and colleges and other institutions, and federally inspected meat and poultry plants.

MILDEW PREVENTION

Reduces the growth of mildew. For 1 week protection, use 1 1/4 fluid ounces per 100 lbs. of dry weight fabric. Retreat as necessary.

Dilute appropriate amount of product in one to two gallons of water; then add to the wash wheel in the final rinse (minimum rinse cycle time of 8 minutes). Retreat fabric after each washing.

For use in federally inspected meat and poultry plants for laundering uniforms or other fabric which does not come into direct contact with food products. Follow directions from above.

Prevents musty odors and discoloration due to mildew, fungi and molds. For use in laundering fabrics. Provides a residual bacteriostatic finish against odor-causing bacteria in laundered fabrics. Helps control most odor-causing bacteria and helps provide a fresh smell. The residual bacteriostatic action protects the fabric by inhibiting growth of bacteria in the presence of moisture or wet contamination.

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician.
