

Formulation HS-65 Swimming Pool Algaecide

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

SWIMMING POOL ALGAECIDE

Effective against *Chlorella pyrenoidosa* (green algae), *Phormidium retzii* (blue-green algae), *Phoridium inundatum* (blue-green algae), *Lyngbya verticillata* (blue-green algae), *Phormidium luridum* (black algae), and *Pleurochloris maringensis* (mustard algae).

INITIAL APPLICATION: For a pool with visible algae present add 25 fl. oz. per 10,000 gallons.

MAINTENANCE DOSE: Use 7½ fl. oz. per 10,000 gallons every week. For very hot weather or heavy bathing load, use this dosage every 5 days.

BOOSTER DOSE: After heavy rains or severe storms add 2½ fl. oz. per 1,000 gallons of water.

POOL-SIDE SURFACES: Pool-side surfaces should first be cleaned with a recommended detergent product.

WHIRLPOOL, SPA AND HOT TUB: Fill whirlpool, spa or hot tub with water. Add ¼ fl. oz. per 100 gallons of water. Drain and disinfect whirlpool, spa or hot tub after each use with a suitable disinfectant. For outside whirlpool, spa and hot tub use only.

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician immediately. If swallowed, drink promptly a large quantity of water. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

CORROSIVE: Do not get in eyes, on skin, or on clothing. Harmful if swallowed. Wash contaminated clothing before reuse. Avoid contamination of food, water, or feed. 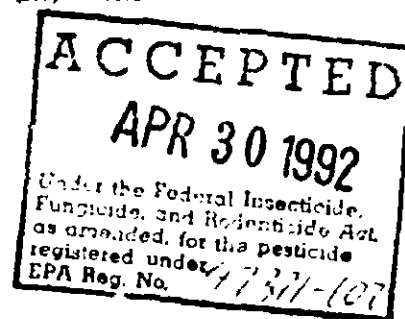

ENVIRONMENTAL HAZARDS

PHYSICAL AND CHEMICAL HAZARDS

Formulation HS-65 Swimming Pool Algaecide is cationic. Do not mix with soap or anionic materials.

STORAGE AND DISPOSAL

This product must be kept under locked storage sufficient to make it inaccessible to children or persons unfamiliar with its proper use. Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

PESTICIDE DISPOSAL

Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. CONTAINER DISPOSAL

PLASTIC CONTAINERS

Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

FIBER DRUMS WITH LINERS

Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of liner in a sanitary landfill or by incineration if allowed by State and local authorities. If drum is contaminated and cannot be reused, dispose in the same manner.

METAL CONTAINERS

Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
