This is to acknowledge receipt of your amendment to revise the labeling for this product. This amendment is acceptable subject to the comments listed below.

The provided information on "Chemia 1117R Spartan Fragrance" is still in review. Thus your Confidential Statements of Formula for the Alternate Formulations dated 7/9/98 and the Basic Formulation dated 12/23/97 cannot be accepted at this time.

As per the Agency letter of September 30, 1998 the following revision must be made to the "Pesticide Disposal" statement in order to comply with PR Notice 83-3. Revise the "Pesticide Disposal" statement to read exactly as it did on the stamped accepted label of 10/15/96 by using the following statements: "Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance."

On page two of the label, move the heading "Farm Premises, Livestock, Poultry & Turkey House Disinfectant" so that it is in the second column of this page and immediately proceeds the specific directions for these types of premises.


