The amendment referred to above, submitted in connection with registration under FIFRA sec. 3(c)(7)(A), is acceptable subject to the following comments.

Efficacy Review

Microbiological data developed by the Official Methods of the AOAC Use Dilution Test Method 15th edition (1990) (MRID 447691-01) was submitted to support 47371-129. This study supports the claims of effectiveness of 47371-130 against *Staphylococcus aureus* (VRSA) a clinical isolate with reduced resistant susceptibility to Vancomycin at a dilution of 1:128 (1.0 ounce/gallon) in the presence of 5% organic soil (fetal bovine serum) and 400 ppm synthetic hard water.

Effectiveness was demonstrated when the diluted product was applied and allowed to remain wet for an exposure time (contact time) of 10 minutes when used on hard, nonporous, inanimate surfaces in the presence of a moderate organic soil and synthetic hard water.


The Agency has no objection to the proposed designation of *Staphylococcus aureus* (HIP-5836) as a vancomycin intermediate resistant <u>Staphylococcus aureus</u> (VISA) strain. The Agency agrees that this designation is both appropriate, more correct, and consistent with the strain designation terminology being promulgated by the Centers for Disease Control.

- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
- A. Make the correction from VRSA to VISA and correctly state vancomycin intermediate resistance next to Staphylococcus aureus on the front center panel of the label.
- B. The Agency has corrected the Agency Internal Use Copy of the submitted Data Matrix such that the MRID for the study submitted to support Staphylococcus aureus (VRSA) reduced resistant susceptibility to Vancomycin reads as follows: 447691-01. Make the same correction to the Data Matrix in your files.
 - C. Change the heading "General Use Directions" to read "Directions for Use".
- D. In the first section under "General Use Directions" delete the phrase "...and other hard, nonporous surfaces." Your label may list additional surfaces, but may not include broad nonspecific statements such as the one previously mentioned. Revise this statement to read "Disinfects, cleans, and deodorizes the following hard nonporous inanimate surfaces: walls, floors, metal surfaces..."
 - E. Change the subheading "Application" to read "Disinfection".
- F. On the center panel the claims "Pseudomonacidal", "Staphylocidal," "Salmonellacidal," "Bactericidal," and "Germicidal" are not allowed since this product does not kill all organisms of the genus Pseudomonas, Staphylococcus, Salmonella, all bacteria, or all germs.
- G. Correct the "Ingredients Statement" by aligning the phrase "100%" such that it is directly under the inert ingredient total of 91.92%.
- H. Since this product may be used in households, a disclaimer statement must be added to the label: "This product must not be used to clean the following food contact surfaces: utensils, glassware, and dishes."
- I. Make the following revision to the "Precautionary Statements." Revise "For eyes, call a physician." to read "For eyes or skin, call a physician."
- J. The "Reusable container statement" is unclear. The Agency requests that you define what is meant by the "use dilution label." Your present label does not include statements for use dilution labeling. Provide copies of this labeling for review by the Agency. Also note that the term "sanitizer" as used in this section is inappropriate for this product since it is not registered as a sanitizer. Until the Agency's concerns regarding this "use dilution label" have been resolved this section of the label must be deleted.

If your label changes are handled through word processing, you should go ahead and address the following comments in addition to the above comments. Please submit a revised label for the Agency's review. However, if you are in the process of printing labels, you will need to submit a label amendment addressing these comments prior to your next label printing.

- K. The use sites, commercial and industrial institutions, need to either be clarified or deleted.
- L. Add specific use directions for disinfection in the following sites you claim: veterinary clinics, animal life science laboratories, pet shops, and kennels. The directions must also indicate specific surfaces for disinfection as well as the removal of the animals from the premises. The same set of directions may be used for all of the previously mentioned sites.
- M. The first section under "General Use Directions" makes claims for disinfecting, cleaning and deodorizing. According to DIS/TSS-15 your product must have <u>separate</u> "Directions for Use" for disinfecting, cleaning and deodorizing. Include directions for cleaning and deodorizing.
 - N. Provide specific directions for fungicidal activity.
- 3. Submit two (2) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, this registration will be subject to cancellation in accordance with FIFRA sec. 6 (e). Your release for shipment of this product bearing the amended labeling constitutes acceptance of these conditions.

OF IIIMAN REMAINS: This product removes body secretions, soil, and blood, along with their accompanying malodor, from the surfaces and orifices of human remains. Using a sponge or washcloth, bathe the entire body with a solution of 1 ounce per gallon of water. A soft handbrush may be employed on surfaces other than the face. Prepare a fresh solution for each remains or when solution becomes visibly dirty or diluted.

FARM PREMISE, LIVESTOCK, POULTRY & TURKEY HOUSE DISINFECTANT

DILUTION: 1:128 1 OUNCE PER GALLON OF WATER

- Remove all animals and feeds from premises, trucks, coops, crates, and enclosures.
