**GENERAL CLASSIFICATION**

**DIRECTIONS FOR SWIMMING POOL CHLORINATION**

For a new pool or for spring cleaning, add one (1) pint (16 fluid oz.) of sodium hypochlorite solution for each 2500 gallons of water. This dosage is equivalent to 5 ppm available chlorine by weight.

**FOR POOL MAINTENANCE**

A) Adjust pool water pH to 7.2-7.6 and maintain.  
B) Add manually or by a feeder, sodium hypochlorite solution at a rate to maintain an available chlorine residual of 0.6 to 1.0 ppm. One half pint (8 fluid oz.) of sodium hypochlorite solution for each 1000 gallons of water will provide 1.0 ppm available chlorine. The frequency of additions to maintain 0.6 to 1.0 ppm available chlorine will depend on temperature and number of swimmers. Use test kit to make certain the pH and chlorine residual are in the proper range.

**NOTE:** This product degrades with age. Use a test kit and increase dosage, as necessary, to maintain proper level of available chlorine.

**STORAGE AND DISPOSAL:** Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container with water and either return to manufacturer or discard by burning, incineration or burying in an approved land fill. Product residue that cannot be used, should be diluted with water and discharged in a sanitary sewer. Do not contaminate food or feed, by storage, disposal or cleaning of equipment.
