DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

Peroquest M 17.5 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 3.3 Peroquest M 17.5 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 to Peroquest M 17.5 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in original container. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a sanitary manner.
