On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.		
Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.		

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
2. As indicated by the Agency's letter of August 6, 2001, you must provide additional efficacy data to further confirm that the cockroach aggregation pheromone is an "active" component in the overall formulation. Testing should be achieved through the testing of boric acid plus inerts vs boric acid plus inerts plus pheromone. The testing should be conducted with one year old formulations to also establish the activity of the formulation overtime. Refer to the enclosed Efficacy Review of July 3, 2001.
3. You must submit the additional efficacy data described in statement No. 2 within one year from the date of issuance of this Notice.
4. You must remove American cockroaches from the label, since the efficacy data does not support the product's use as a bait for this pest. Since this product is distinguished primarily as a bait formulation, it would be inappropriate to list American cockroaches as a pest, until further efficacy data is submitted and approved showing this product's effectiveness as a bait formulation on this pest.
5. Make the following label changes:
 - a. Revise the EPA Registration Number to read, EPA Reg. No.47629-3

"Have the product container or label with you when calling a Poison Control Center or doctor or going for treatment".



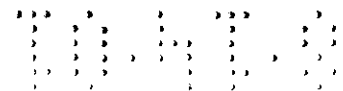
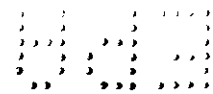
