Purpose

For each product, the purpose of the submission, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is to revise your label, into three (3) distinct sublabels: 1. Consumer Use, 2. Agricultural Building Use, and 3. Professional Use.

Professional Use.

Labeling

For each product, the labeling submitted with the above letter is acceptable, provided that you submit one (1) copy of final printed labeling to us, with the following changes, before you ship the product.

1. Revise your "PRECAUTIONARY STATEMENTS" according to Enclosure 1.

Labelingcontinued

2. In the "Use Restrictions", after "or meat", add this sentence:

Do not use in edible product areas of food or feed processing plants or other areas where food or feed is commercially prepared or processed.

- 3. Bold "Do not apply further than 50 feet from buildings."
- 4. Add "only" after "agricultural buildings" [Agricultural Building Sublabel only]
- 5. Move the following sentences to the end of the section in their own paragraph, for emphasis:

Do not sell this product in individual containers holding less than 8 pounds of bait. [Agricultural Building Use Sublabel]

Do not sell this product in individual containers holding less than 16 pounds of bait. [Professional Use Sublabel]

- 6. In your "Storage and Disposal" text, use Enclosure 2 to revised your text.
- 7. Delete the following text after "incineration", wherever it occurs:

"or if allowed by state and local authorities, by burning; if burned, stay out of smoke."

Existing stocks

Stocks of products with existing labels may be used for 18 months.

Consequence for non-compliance

If these conditions are not complied with, the registrations will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the products constitutes acceptance of these conditions.

Conditions of Approval

These registrations are not consistent with the Agency's May 28, 2008, "Risk Mitigation Decision for Ten Rodenticides." EPA anticipates cancellation of those existing products that are not consistent with the Risk Mitigation Decision to occur no later than June 4, 2011. In the meantime, EPA is approving new registrations and amendments to existing registrations of rodenticide bait products, on a time-limited basis, so long as the registrations do not present greater risks of unreasonable adverse effects than existing products. Accordingly, these registrations are approved only subject to the condition that the registrations shall expire on June 4, 2011. This condition of registration may be amended in conjunction with amendments to conform to the Risk Mitigation Decision. Absent such amendments, product released for shipment by the registrant after June 4, 2011, would be in violation of FIFRA.
