Purpose The purpose of each submission under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is to revise your label, to increase the additional package sizes/net contents for the above products.

Review All of the proposed additional packages sizes meet or exceed the minimum application amounts approved for claims of control of both rats and mice.

Conditions of Approval

This registration is not consistent with the Agency's May 28, 2008, "Risk Mitigation Decision for Ten Rodenticides." EPA anticipates cancellation of those existing products that are not consistent with the Risk Mitigation Decision to occur no later than June 4, 2011. In the meantime, EPA is approving new registrations and amendments to existing registrations of rodenticide bait products, on a time-limited basis, so long as the registrations do not present greater risks of unreasonable adverse effects than existing products. Accordingly, this registration is approved only subject to the condition that the registration shall expire on June 4, 2011. This condition of registration may be amended in conjunction with amendments to conform to the Risk Mitigation Decision. Absent such amendments, product released for shipment by the registrant after June 4, 2011, would be in violation of FIFRA.

Label

For each product, the labeling submitted with the above letter is acceptable, provided that you submit one (1) copy of final printed labeling to us, with the following changes, before you ship the product.

Under "STORAGE AND DISPOSAL", revise your "Disposal" text [Household Label] and revise "Container Disposal" to "Container Handling" [Non-Household Label] followed by instructions for each type of container. In general, you will be adding the new text required by the "Container Regulations" (40 CFR 156.140 - .159) and explained in PRN 2007-4 to the existing container disposal instructions.

We have suggested an acceptable text in Enclosure 2. Contact us if you need assistance in developing correct text. Also, all products distributed or sold in nonrefillable containers will need batch codes on the label or the container.

Consequence for non-compliance

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of these product constitutes acceptance of these conditions.

All placements of this product in USDA-inspected facilities must be in tamper-resistant bait stations. Do not broadcast bait. Wear water-resistant gloves when handling bait.

Urban Areas: This product may only be used in and around homes, industrial, commercial, and public buildings, and similar man-made structures; in transport vehicles (ships, trains, and aircraft) and in and around related port or terminal buildings; and in alleys. All outdoor bait placements must be made in tamper-resistant bait stations, locked and secured as necessary, unless children, pets, domestic animals, and nontarget wildlife are reliably denied access to the bait placement locations.

Non-urban Areas: This product may only be used inside of homes, and agricultural buildings.

SELECTION OF TREATMENT AREAS: Determine areas where rats and mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, beside burrows, in corners and concealed places, between floors and walls, or in locations where rats, mice, or their signs have been seen. Maintain an uninterrupted supply of fresh bait for at least 10 days or until fresh signs of feeding by rats cease to appear.

House Mice: Open [place pack][bait pack][bait bag] and apply ¼ to ½ ounce of bait per placement, using tamper-resistant bait stations as required under “**IMPORTANT**”. Space placements at intervals of 8 to 12 feet in infested areas pertaining to structures. Larger quantities (up to one unopened 1.5 ounce [place pack][bait pack][bait bag]) may be placed in areas of extremely high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until fresh signs of feeding by mice cease to appear.

Follow-up: Replace contaminated or spoiled bait immediately. Using water-resistant gloves, collect and properly dispose of dead animals and leftover bait, as well as any bait that has become accessible to non-target animals. To discourage re-infestation, limit sources of rodent food, water, and harborage as much as possible. If re-infestation does occur, repeat treatment. For continuous sources of infestation, set up permanent bait stations and replenish them as needed.
