Cosco Golden Solution Humidifier Bacteria Water Treatment is a product to effectively control lime scale build up, and control growth of odor causing bacteria and algae in console type (manually filled) humidifiers. Used as directed, it is guaranteed to perform as stated on the label in the water tanks of all console humidifiers.

### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Be sure your humidifier and its filter are thoroughly clean before each heating season (use of Cosco Solution 26 Humidifier Descaler is recommended for this purpose).

For every gallon of water contained in the humidifier tank, add no more than one capful (8ml.) of Golden Solution. Fill cap to top. When refilling, add only one capful of Golden Solution for every additional gallon of water.

Note: wheel type humidifier belts may sometimes need to be gently hand started.

Not for heat vaporizing or atomizing type vaporizer humidifiers.
