
Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec 3(c)(5) when the Agency requires all registrants of similar products to submit such data.

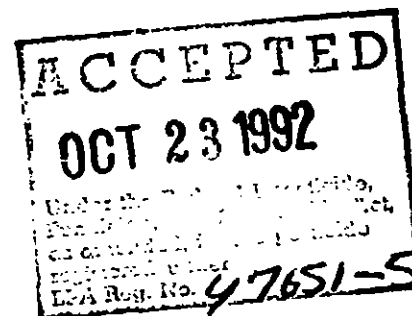

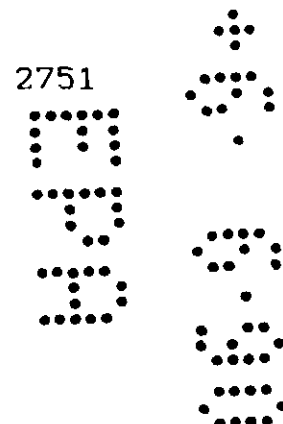

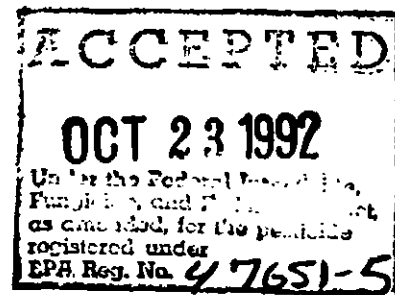
